

↗ **Appraisal**

Replacement method, formula method, or cost of cure, for legal, insurance or planning purposes.

↗ **City/County Reports**

Removal or preservation reports to city or county standards.

↗ **Diagnostics**

Shigometer, starch tests, penetrometer, root investigation, and site evaluation.
